- i. The Licensee permitted the place where he or she is licensed to sell beverages to become disorderly and to annoy and disturb the persons inhabiting or residing in the neighborhood in violation of RIGL 3-5-23.
- ii. The Licensee conducted one or more special events without first obtaining prior approval before the issuance of a license for each event in violation of the Code of Ordinances, Chapter 174.
- iii. The Licensee conducted or operated musical performances with outside electronic amplification in violation of the conditions of the license issued pursuant to Code of Ordinances, Chapter 173.
- iv. The Licensee conducted or operated musical entertainment with electronic amplification that constituted or resulted in a public nuisance.
